AN ORDINANCE ANNEXING INTO THE TOWN OF YEMASSEE, ONE PARCEL OF LAND TOTALLING 0.49 ACRES, LOCATED AT 64 WESLEY DRIVE, OWNED BY REATHER MAE MICKENS, IN HAMPTON COUNTY, NOT ALREADY WITHIN THE YEMASSEE TOWN LIMITS AND WITH ALL ADJACENT PUBLIC RIGHTS OF WAYS AND WETLANDS.

Section 1. Findings of Facts

- d) The Town Council is zoning the property General Residential.
- e) The Yemassee Town Council finds the proposed annexation and rezoning is consistent with the Yemassee Comprehensive Plan (as amended and revised);
