A RESOLUTION OF THE TOWN OF YEMASSEE, SOUTH CAROLINA, TOWN COUNCIL TO APPROVE THE PUBLIC PROJECT APPLICATION OF PALMETTO RURAL TELEPHONE CO FOR PHASE 1 OF THEIR FIBER OPTIC BUILDOUT IN THE TOWN OF YEMASSEE AND TO AUTHORIZE THE EXECUTION OF AN EASEMENT FOR PALMETTO RURAL TELEPHONE CO TO INSTALL COMMUNICATIONS EQUIPMENT ON TOWN PROPERTY

WHEREAS, pursuant to the Town of Yemassee Ordinance, Palmetto Rural Telephone Co has submitted a Public Project Application for the construction of a fiberoptic buildout for telecommunications infrastructure; and

WHEREAS, Town Staff have reviewed the application which contained framework for Phase 1 of their fiberoptic buildout which covers the area west of US Hwy 17A, north of SC-68 and east of Gordon St; and

WHEREAS, approval of the project is in the best interest of citizens and business owners alike and will provide options for fiberoptic internet, tv and phone services; and

WHEREAS, the applicant is requesting an easement covering a 15 x 20 area on the municipal complex property on the southwest corner of the parcel, abutting Zahler St E; and

WHEREAS, Palmetto Rural Telephone will handle all maintenance of the natural vegetative buffer around the easement to ensure it does not detract from the aesthetics of the area.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF YEMASSEE AS FOLLOWS:

The Town Council of the Town of Yemassee hereby approves the Public Project Application for Phase 1 of the Palmetto Rural Telephone Buildout and authorizes the Mayor to execute an easement over a 15 x 20 portion of land on the Yemassee Municipal Complex property. (Exhibit A)
