Town of Yemassee Town Council Meeting May 14, 2019 6:30 P.M.

The Town of Yemassee Council held its regularly scheduled Town Council meeting on Tuesday May 14, 2019 at 6:30 at the Municipal Complex, in Yemassee, South Carolina. Present: Mayor Colin Moore, Council Member(s) – Chuck Simmons, Peggy O'Banner & Alfred Washington. Absent: Council Member Michelle Hagan. Staff present: Town Clerk Matthew Garnes & Administrative Assistant Verlynda Singleton.

Determination of Quorum:

Mayor Moore was present. Council Member(s) Simmons, O'Banner & Washington were present. Council Member Hagan was absent. Meeting was opened at 6:33PM. Council Member O'Banner gave the Invocation and the Pledge of Allegiance.

Adoption of Agenda:

Council Member O'Banner made the motion to approve the agenda as presented, Second by Council Member Simmons. All in favor.

Approval of Minutes:

3a) Council Member O'Banner made the motion to approve the April 8, 2019 Town Council Meeting Minutes as presented. Second by Council Member Washington. All in favor.

3b) Mr. Garnes presented the meeting minutes from March 5, 2019 that were previously contested by Council Member Simmons. Council Member Simmons advised he still had issues with the motion for item 5.2. Discussion amongst the Council continued. Mr. Garnes said he played back the recording with Ms. Singleton and they both heard the recording which confirmed the minutes as presented. Mayor Moore suggested to Council Member Simmons to come in and play back the tape during the next month.

Proclamations:

4a) Council Member O'Banner read the proclamation on Small Business Week which was then signed by Mayor Moore.

4b) Council Member O'Banner read the proclamation on National Safe Boating Week and presented the Proclamation to the United States Coast Guard Auxiliary Flotilla 10-1 that was in attendance.

Formal Items:

5a) Mayor Moore read the Ordinance amending the Town of Yemassee Schedule of Rates & Fees. He reminded the attending public that this brought the outdated fee schedule up to date and removed fees that no longer applied such as fees that the Town assessed when the Town maintained its own Water Department. The new fee schedule also includes fixed fee amounts for residential and commercial building permits and mobile home permits. Council Member O'Banner made the motion to approve the Ordinance. Second by Council Member Simmons. All in favor.

5b) Council Member Washington made the motion for first reading on Annexation Ordinance 19-03 annexing approximately 1.00 acre of land on John Street. Council Member O'Banner advised she would be abstaining on the vote due to a conflict of interest. During the discussion, Council Member Simmons pointed out a discrepancy on the Agenda and the Ordinance with the name of the property owner. Council Member Simmons objected to the issue and stated that he would like to not move forward on the Annexation until it was corrected on the agenda and would like to table it accordingly. Council Member Simmons made the motion to table the first reading until the next meeting. Second by Council Member Washington. Council Member O'Banner abstained. Motion carried.

5c) Council Member O'Banner made the motion for first reading on Annexation Ordinance 19-04 annexing approximately 0.50 acres of land located at 207 Bing Street. Second by Council Member Simmons. All in favor.

5d) Council Member Simmons made the motion for first reading on Annexation Ordinance 19-05 annexing approximately 18.00 acres of land located at 1322 Salkehatchie Road. Second by Council Member O'Banner. All in favor.

5e) Council member O'Banner made the motion for first reading on Annexation Ordinance 19-06, annexing approximately 2.00 acres of land located at 1755 Salkehatchie Road. Second by Council Member Washington. All in favor.

5f) Mayor Moore read Ordinance 2019-1012 amending the Town of Yemassee Fiscal Year 2019 Budget to Recognize Additional Expenditures and to Allocate Sources of Revenue for all Funds. Mayor Moore explained that the budget is being amended to increase projected revenues on Business Licenses, Local Hospitality Tax, Victim Services, Homestead Exemption & Manufacturers Reimbursement. The amendment adds a new line to the General Fund budget under Administration for Festival Office utilities. This is meant to categorize utility bills specifically for the Festival Office, keeping it separate from Town Hall utilities. The LRWS Franchise fee line is being reduced from \$45,000 to \$15,000 due in part to constituents being more conservative with their use of water & wastewater services. The Police Department Auto Maintenance line is being amended from a \$30,000 budget to \$50,000 with the \$20,000 being moved from the Contingency Fund. Council Member O'Banner made the motion for first reading. Second by Council Member Washington. All in favor.

5g) Mayor Moore read the resolution authorizing the Town Clerk to execute an application on behalf of the Town of Yemassee, for enrollment and subsequent membership in the South Carolina State Insurance Benefit Program (PEBA) and complete the associated enrollment steps. Council Member Washington made the motion to approve the resolution. Second by Council Member Simmons. All in favor.

Department Reports:

6a) Chief Alexander reported that they have received three used police vehicles from the surplus pool at the North Charleston Police Department. This week is National Law Enforcement Appreciation Week and encouraged everyone to thank a Police Officer if you see one for the good job that put in each day. Chief Alexander advised that August 7th is National Night Out in Yemassee. This is the 4th year that the Town has done it and we look forward to hosting it again. Council Member O'Banner wished to thank the Police Department for fantastic work they do for the Town. Council Member O'Banner also asked Chief Alexander if the Police Department would be able to help her at a BBQ event she is looking to host at the Town Hall on June 29th. The event will be named "Books, Bubbles and Burgers" and all are welcome to attend.

6b) Mr. Garnes reported on behalf of the Recreation Department. He advised that the Town has installed additional playground equipment such as plastic mulch and barriers for the mulch at Moore's Park and more equipment is slated to be delivered next week. Mr. Garnes also reported that the Harold Peeples Field concession stand has been opened now and has been turning a good profit and selling food at the games.

6c) Mr. Garnes gave a report on the Administrative Department.

Committee Reports:

7a) Mr. Goodwin from the Train Station Restoration Project reported that the Train Station upgrades are progressing along well. The floor should be stained next week and then some final painting should be done. He advised that the contract with Amtrak specifies that they will provide a Janitor and they currently do not. Mr. Goodwin would like the Town to look into this. Council Member Simmons suggested getting together with Amtrak to work on getting them to

provide the Janitor. Mr. Goodwin also reported that there is a small library in the waiting room that a town resident operates and asked if anyone had any children's books that they would not mind donating to the Library.

7b) Festival Committee had no report

7c) Mr. Garnes gave a report for the Section 504 Committee. The Committee has met several times over the past month and has nearly finished evaluating all the Town owned properties for ADA compliance. The next step will be drafting a Transition Plan to outline the steps the Town can take to implement the necessary fixes to become ADA compliant.

Public Comment:

8a) <u>Douglas Mickens (64 Wesley Drive)</u> - Mr. Mickens wished to update the Council and attending public on the efforts and outreach that has occurred in Zone A. Last week they initiated a litter pickup on Cochran Street from SC-68 to Riley Street and picked up over 20 bags of trash and several tires. Mr. Mickens was disappointed to report that not even a week later there was trash strewn along Cochran Street once again and encouraged the residents throughout the Town in other zones to pitch in and do their part to clean up their neighborhoods. Mr. Mickens asked if the Town would be able to provide bags and ice water. Council Member Simmons informed them the Town would provide all the trash bags and ice water they would need. Mr. Mickens also inquired if the Town had filled the Public Works position to which Council Member O'Banner replied that the part time position had been filled and the Town is still seeking an applicant for the full-time position.

Executive Session:

Mayor Moore advised that the Council needed to enter Executive Session to discuss two items; the first being the discussion of negotiations incident to proposed contractual arrangements and proposed sale or purchase of property, the receipt of legal advice where the legal advice relates to a pending, threatened, or potential claim or other matters covered by the attorney-client privilege, settlement of legal claims, or the position of the public agency in other adversary situations involving the assertion against the agency of a claim. The second item for discussion in Executive Session was regarding the development of security personnel or devices. Council Member O'Banner made the motion to enter Executive Session. Second by Council Member Simmons. All in favor. The Council entered Executive Session at 8:02PM.

Council Member Washington made the motion to leave Executive Session, Second by Council Member O'Banner. The Council adjourned Executive Session at 8:29PM.

Mayor Moore advised that the Council discussed the outcome of the bids received in regards to the Solid Waste RFP. The current contract with Republic Waste ends on September 30, 2019. The Council has decided to award the contract for a five-year period to S&S Disposal beginning October 1, 2019. Council Member O'Banner made the motion. Second by Council Member Simmons. All in favor.

Mayor Moore asked for a motion to adjourn. Council Member O'Banner made the motion to adjourn. Second by Council Member Washington. All in favor. Meeting adjourned at 8:32PM.

- 5.2 Council Member O'Banner made motion to approve the second reading on an Ordinance 2.305 amending the Yemassee Municipal Code, Article III, Section 2.305. Second by Council Member Hagan. All in favor.

Presentation of FY17/FY18 Audit

6.1 Bill Hancock had a family emergency and was unable to attend the meeting tonight. He advised that he will be here at the regularly scheduled meeting in April and apologized for the inconvenience.

Department Reports:

7.1 <u>Police Department</u> – Chief Alexander wished to thank those who came to the opening ceremony for the Yemassee Police substation. Many people were shocked with how nice the building looked on the inside. Chief Alexander invited everyone to the National Crime Victims Right Week Vigil on Monday April 8, 2019 at the Town Hall. The event is being coordinated by our Crime Victims Advocate, Mrs. Pinckney. Chief Alexander also wished to commend Corporal Watson for a job well done. Ms. Davis from 72 Reeves Street got up and read a

letter that she wrote regarding a response to her house in which Corporal Watson responded. Corporal Watson arrived at the residence and immediately began performing CPR and continued doing so until the Fire Department arrived and stayed with the family for quite some time afterwards to see if there was anything the Yemassee Police Department could provide. Ms. Davis extended her deepest appreciation to Corporal Watson and the Yemassee Police Department.

7.2 <u>Recreation Department</u> – Council Member Simmons advised that he has almost finished up the bargaining with the quotes for some additional playground equipment.

Committee Reports:

8.1 Mr. Goodwin reported that the electrical meters are in and will be ready for permanent service inspections within the next week or so.

Public Comment:

9.1 <u>Paul Holmes (573 Ridgecut Road) –</u> Mr. Holmes wished to inquire about the town's annexation practices. Mr. Holmes had a flyer that has been circulated by an individual the Early Branch area both on Facebook and in person that is spreading misconceptions regarding annexations by the Town of Yemassee. Mr. Holmes wanted to know if the Town was attempting to annex Early Branch and Ridgecut and bring water and sewer along with it. Council Member Hagan wished to dispel the rumors that the Town was trying to expand through Early Branch and Ridgecut and told the attending public that the Town would only extend as far as the last person that signs a petition. Additionally, the Council informed the attending public that the town does not control their growth.

Adjournment:

Mayor Moore asked for a motion to adjourn the meeting. Motion to adjourn was made by Council Member O'Banner, second by Council Member Hagan. All in Favor. Meeting Adjourned at 7:28pm.

- b) A proper Petition has been filed with Town of Yemassee by one hundred percent (100%) of the freeholders owning one hundred percent (100%) of the assessed value of the contiguous property herein described, petitioning for annexation of the property to the Town of Yemassee under the provisions of South Carolina Section 5-3-150(3) and is requesting the Town's zoning of General Residential and have submitted proper submission materials supporting each application in accordance with Town requirements.
- c) It appears to Town Council that the annexation would be in the best interest of the property owners and the town.
- d) The Town Council is zoning the parcel General Residential.
- e) The Yemassee Town Council finds the proposed annexation and rezoning is consistent with the Yemassee Comprehensive Plan (as amended and revised);
