PRESENT: Mayor Cook, Council Member Moore, O'Banner, Jinks, Anderson and Clerk Misty Reardon.

INVOCATION: Invocation was given by Mayor Cook.

PLEDGE OF ALLEGIANCE: Given by Council Member O'Banner.

<u>ACTION ON MINTUES FROM JULY 12TH 2016:</u> Motion to amend minutes for a later time. First in favor by Council Member Anderson second by Council Member Jinks. All were in favor.

<u>DETERMINATION OF QUORUM</u>: Mayor Cook and Entire Town Government were present.

DETERMINATION OF NOTICE OF PRESS: Press has been notified by fax.

<u>DISCUSSION OF STREET SIGNS:</u> Council Member Jinks is inquiring about street signs for the town of Yemassee. Chief Alexander informed council that Officer Watson was making a list of which signs in the town needed to be updated. Council Member Jinks said he would call Mayor Michele of Gifford County and see if they purchased signs for their county yet and if not to see if we couldn't purchase the signs together.

<u>PISCUSSION OF THE DOG POUND:</u> Mayor Cook made the motion to open back up Yemassee dog pound, due to Hampton County animal control not holding up to their contract in providing the services that the Town of Yemassee needs. Mayor Cook asked the Clerk Ms. Reardon to look into the contract before taking any further actions. First in favor by Council Member Jinks, second by Council Member Moore. All in favor.

PUBLIC PARTICIPATION: Donna Baker asked about the grant that are coming up and Council Member Jinks informed her that we sent to get the grant for the recreation department. Police Chief Alexander wanted to thank everyone for the good turn out on the light out event and wanted to personal thank mayor cook for the banner that he and his wife gave to the police department. Police Chief Alexander presented Mayor Cook with a gift for the banner and his support for the event. Council Member O'Banner also wanted to congratulate Chief Alexander on his invitation to the White House in Washington D.C. for the police chief's.

OLD BUSINESS: Council Member Anderson made the motion for himself and Council Member Jinks to go to Columbia to get an updated mapping and zoning of the town, first in favor Council Member Moore, second by Council Member Jinks.
