Mayor Moore read Annexation Ordinance 20-10 for the Atlanta Presbyterian Church at 318 Trask Pkwy & 33 Stoney Creek Cemetery Road in Beaufort County. Council Member O'Banner made the motion to approve second and final reading. Second by Council Member Washington. All in favor, **Motion Passed**.

1st Readings:

Mayor Moore summarized the proposed ordinance amending the Town of Yemassee FY20 budget to account for revenues brought in and allocating expenses across the budget. The Town received multiple grants during the year and needed to shift around other projections to balance the budget. Council Member Washington made the motion to approve first reading. Second by Council Member O'Banner. All in favor, **Motion Passed**.

Mayor Moore read resolution authorizing the Town Clerk to solicit for volunteer applicants. This will allow the town to formally solicit online and via other mediums for applicants seeking appointment to Town Boards & Commissions. Council Member Washington made motion to adopt resolution.
