### POLICE DEPARTMENT

7.1 Police Chief Gregory Alexander first wished to congratulate the Shaw family on being annexed into the Town of Yemassee and reminded them that he is just a phone call away. Officers from the Yemassee Police Department participated in "Operation Rolling Thunder" which took place in Cherokee & Spartanburg Counties last week. In total, 1200 traffic stops were conducted, 48 arrests made, 9000 ounces of marijuana, 4000 grams of Methamphetamine, 900 grams of cocaine, 273 grams of miscellaneous drugs were seized. 25 Felony arrests and 9 fugitive from justice arrests were also reported. Chief Alexander advised the operation was a great success.

Chief Alexander reported that Shemuel Nahuem Ben Yisrael at 18 Wall Street damaged the fence on town owned property late last week. Yisrael led officers on a vehicle chase to the Beaufort City limits, where the pursuit was terminated due to unsafe conditions. Yisrael surrendered himself to Beaufort County Sheriff's Deputies and was subsequently arrested and booked into the Beaufort County Detention Center. A quote has been received for repairs to the fence. A camera system quote has also been obtained totaling \$1700 and will be placed on the train station roof.

The Fire Department along with Yemassee Police were dispatched to a suspicious house fire last night on Josselson Street. The SLED Arson team was requested at the Chiefs direction. More to follow.

- 7.2 Discussion took place regarding the Dispatching services with Hampton County Dispatch for emergency dispatch services. Chief Alexander advised him and Mayor Moore spoke with the Beaufort County Sheriff and Lt. Col. Neil Baxley with BCSO Dispatch who advised they currently lack adequate staffing to take Yemassee back on board. The Town of Yemassee will pay Hampton County \$7318 a month for six months which will cover charges dating back to when Yemassee came on board with Hampton County in December of 2016 and will revert back to \$2500 a month after the six month period has ended.
- 7.3 Council Member Washington made the motion to pay the Invoice from TireMaxx in the amount of \$1004.01 for police vehicle tires. Second by Council Member O'Banner. All in favor.

#### AUDITORS REPORT

8.1 Mr. Bill Hancock from The Brittingham Group addressed the Mayor & Council along with the attending public. He stated that with any change in management it is expected that there will be changes in bookkeeping practices and specific ways that records are kept. "Mr. Garnes has reached out to me on three occasions and I have conducted one visit to check up on everything. At that time he was still getting all the information together and had not yet reconciled March, however as of now March and April for all 18 accounts have been reconciled.". Mr. Hancock advised that the Town may need to look at a budget amendment with the addition of a secondary full time Public Works department employee and the addition of a 911 Dispatch fee. Mr. Hancock will meet with Mr. Garnes in the coming weeks to review the budget and devise a budget amendment to carry the town through for the remainder of the fiscal year.

#### **PUBLIC COMMENTS:**

Mr. Darrell Russell (Yemassee, SC) introduced himself as candidate for Hampton County Council at large. His platform is transparency, improvement in public safety services and smart planning.

Ms. Donna Singleton Baker (Yemassee, SC) Addressed issues with flooding on Railroad Avenue North during last month's heavy rain storm. She advised that her driveway was damaged and it had appeared that the storm water drains were clogged. Council Member Washington advised Ms. Baker that there is a known problem with the storm water drains and that Lowcountry Regional Water System is bringing in a vacuum truck in the coming weeks to rectify that issue.
